## 1. REVISIONS TO SPECIFICATIONS

### 1.1 DELETE Section 1.13 - Emergency Collection

Section 1.13 (**Emergency Collection**) (page 13 of the Project Specifications) is hereby deleted in its entirety. All references throughout the Contract Documents to Section 1.13 shall be read as though that section has been removed.

### 1.2 AMEND Section 3.1

In Section 3.1 of the Project Specifications (and any cross-references), remove the phrase “**according to areas defined in Attachment #3.**” so that the sentence(s) in Section 3.1 read without that phrase. All other wording in Section 3.1 remains unchanged.

## 2. REVISED BID OPENING DATE / TIME / LOCATION
